## GRAND ENCAMPMENT SWORD AND DRILL COMPETITION INSTRUCTIONS FOR CYRENES/TEMPLAR CRUSADERS AND SIR KNIGHTS



Sword and Drill competition is open to all Cyrenes/Templar Crusaders and Sir Knights of all Courts and Commanderies that are current members of the Grand Encampment and International Grand Courts of the Cyrene Crusaders, Prince Hall Affiliated of the United States.

Each team in competition must adhere to the following guide lines and standards for participation:

1. The Cyrenes/Templar Crusaders will compete against their respective competitors from other Courts. The Knights Templar will compete against their respective competitors from other Commanderies.
2. There are two types of uniform that may be worn in competition by the males. There can be no mixture of the uniform per team in competition. The uniforms are listed as **Category I uniforms** consist of Frock Coat, Chapeau, Sword and Belt. **Category II uniforms** consist of Fatigue Coats, Chapeau or Fatigue Cap, Sword and Belt.
3. The Cyrenes/Templar Crusaders complete uniforms must all be of the same style and format.
4. Each MALE/FEMALE team must have 5 or more pre-registered members. There will be no registration of participating team members on-site.

There is a **\$40.00** advance entry fee per team, with a deadline date for submission. There is an additional **\$10.00 late fee for late postal date receipt** of team's application.

All teams entered will have to demonstrate the following:

1. All facing movements (left, right, about, etc)
2. All Column movements
3. Marching at a full and half step pace
4. Close Order drill

**All Sir Knights must exemplify ALL SWORD CUTS**

**There is a 12 minute time limit per team, with a two minute warning before penalty points will be assessed. This is strictly enforced.**

There will be a 1 point penalty for each overage minute or portion of a minute

**No member of the judging Team will be allowed to participate in scoring if he or she is affiliated with a team in competition from his or her jurisdiction.**

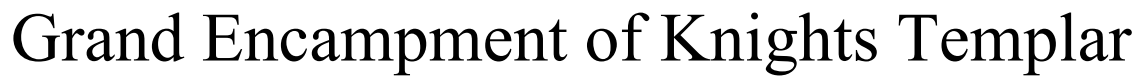
